



UNDERTAKING

I, ANJALEE MARWAHA, W/O SANDEEP MARWAHA, 4710, DARSHAN VIHARM, SECTOR 68, MOHALI I am President of **RAI'S EDUCATIONAL SOCIETY, HIG-143, SECTOR 71, SAS NAGAR MOHALI (PUNJAB)** running the school **ST. THOMUS CONVENT SCHOOL, VILLAGE SUNDERPUR, SRS LOTUS GREEN CITY, SECTOR -9, KURUKSHETRA** hereby affirm and declare as under:-

1. That the grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond.
2. That the school shall be by the provision of Right of Children to Free and Compulsory Education Act. 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
3. That the school shall ensure that:-
 - (i) The school shall admit in class I, to the extent 25% of the strength of that class. Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion:
Provided, that in case of pre primary classes also, this norm shall be followed.
 - (ii) The school shall admit in class 1ST to 12th under rule 134-A to the extent of 10% of the strength to that class for meritorious students belonging to economically weaker section.
4. That for the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.
5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. That the school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.
7. That the school shall ensure that:-
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - (ii) No child shall be subjected to physical punishment or mental harassment;
 - (iii) No child is required to pass any board examination till the completion of elementary education.
 - (iv) Every child completing elementary education shall be awarded a certificate as laid down under rule 22;
 - (v) Inclusion of students with disabilities/Special needs as per provision of the Act.
 - (vi) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this

- Act do not posses minimum qualification shall acquire such minimum qualification with in a period of 5 years.
- (vii) The teacher performs its duties specified under section 24(1) of the Act; and
 - (viii) The school teacher not engage himself or herself for private teaching activities.
8. That the school shall follow the syllabus on the basis of curriculum laid down by academic authority.
 9. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.
 10. That the school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under.
 - (i) Area of school campus total built up area.
 - (ii) Area of play ground.
 - (iii) Number of class rooms
 - (iv) Room for Headmaster-Cum-Office-cum-Storeroom
 - (v) Separate toilet for boys and girls
 - (vi) Drinking Water Facilities
 - (vii) Kitchen for cooking Mid Day Meal.
 - (viii) Barrier free Access.
 - (ix) Availability of Teaching Learning Material/Play Sports Equipments/Library.
 11. That no unrecognized classes shall run within the premises for the school or outside in the same name of school.
 12. That the school building or other structures or the grounds are used only for the purpose education and skill development.
 13. That the school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
 14. That the school should be audited and certified by a Chartered Accountant and proper account statements should be prepared as per rule A copy of the statements of accounts should be sent to the District Elementary Education Officers every year.
 15. That the reorganization code Number allotted to your school isThis may please be noted any quoted for any correspondence with this office.
 16. That the school furnishes such reports and information as may be required by the Director of Education/District Elementary Education Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfillment of the conduction or recognition or the deficiencies in working of the school.
 17. That the Renewal of Registration of Society, If any be ensured.
