Rules And Regulations

GOVERNING BODY:-

All the office bearers shall constitute the governing body

It shall manage all the affairs of association with the help of executive committee

Governing body and executive committee shall do everything, deed and act for the attainment of aims and objectives of the association.

EXECUTIVE COMMITTEE:-

That the Eight members including the members of governing body shall constitute the Executive Committee

FUNCTIONING OF SOCIETY

(a) The Society shall work within the ambit of societies Registration Act, 1860 as amended upto date

(b) The funds of the society shall be spent for such purpose only as have been defined as charitable under the income tax Act, or any other law governing exemption for Charitable purposes

QUORUM

The quorum of the meeting of the General or executive body should be 1/2, present in the meeting

MEMBERSHIP

1. The President is the founder Chairman of the Society...
2. Any adult person who believes in the aims and objects of the society can become a member of the society
3. Any adult person who wants to become a member of the society must be passed in the General Meeting by 2/3 majority in the voting of the members present.

REMOVAL OF MEMBERSHIP

1. Any member of the society who does not work for the betterment of the aims and objects of the society can be removed from the membership by a 2/3 majority at the voting of the members present in the meeting.
2. The Chairman may drop any member from the society with any written or verbal notice at any time in case he thinks and feels satisfied that a particular member of the society is not proving helpful in the furtherance of the aims of the society in its institutions.

MEMBERSHIP FEE

The monthly membership fee of the Society is Rs. 20/- (Rupee Two only). The Chairman however may exempt any member from paying the membership fee.

MEETING OF THE SOCIETY

1. The General Body must meet once in a year.
2. The Executive body must meet quarterly.
3. The Chairman may call an emergency meeting whenever he think it necessary.

NOTICE FOR MEETING

1. At least one week's notice should be given to every member of the society before a meeting.
2. In an emergency meeting, twenty four hour's notice should be given before the meeting.

TERMINATION OF THE EXECUTIVE BODY

1. The Chairman is the founder of the society. He is Chairman for life time.
2. The Other executive members of the society can be removed by a 2/3 majority present in the meeting after passing the resolution in the meeting.

APPOINTMENT OF THE EXECUTIVE MEMBERS

1. Only the chairman can nominate or appoint the members of the General Body with the sanction of General Meeting.
2. The Chairman can also nominate the honorary members of the society.

POWER AND FUNCTION OF THE GENERAL BODY

It shall give advice to the executive for the promotion and furtherance of the cause of the society. It shall consider the proposals which is put to it by the executive committee, it shall bear the report of the working of the society from the secretary and her/his press views in that report.

POWER AND FUNCTION OF THE GOVERNING BODY

The Governing Body will decide how to make correspondence with the authorities or other departments to fulfill the aims and objects of the society. It will also decide how to spend the donational grants assistance and for what purpose, when the General Body meeting are to be conducted, prepare the agendas of the meetings, check the accounts of the society. The Governing Body can borrow loan finances from any bank or from private body in India for running and maintenance of the institutes.

CHAIRMAN OF THE MEETINGS

Mr. Sandeep Marwaha shall be the Chairman of the Society. The Chairman will preside over all the meetings of the Governing and General Body.

POWER AND FUNCTION OF THE CHAIRMAN

He has the power to sanction expenditure upto any limit with the approval of the governing body. He can appoint/ nominate honorary members of the society. He can call an emergency meeting of the governing as well as the General Body. He can use all the power given to him from time to time.

PROPERTY OF THE SOCIETY

All income thus acquired by the society and its institutions from property of the society and from any source and shall be the property of the society.

AMENDMENTS IN THE CONSTITUTION

1. For amendments in any clause of the constitution, one week's notice will be issued to the Governing Body under the signatures of the chairman for calling the general meeting.
2. The amendments should be passed by the 2/3 majority of the members present and voting in the meeting.

ADDITION OF THE CLAUSE IN THE CONSTITUTION

The Chairman can make any addition in the constitution when he feels necessary with the sanction of the General Body by a majority of 2/3 of the members.

DISSOLUTION OF THE SOCIETY

1. The society can be dissolved only 2/3 majority of voting of the society

3. The society shall not be dissolved unless 2/3rd of the total members shall express a wish for dissolution by their votes delivered in person or by proxy at a general house meeting for that purpose.
